All groups must consist of 20 or more people with one contact person for the group. Full payment must be made with a credit card or check with in 30 days of the reservation. Group contracts must be signed and returned with payment. Groups that have not signed their contract will have any reserved seats released. Our excursions are ROUND TRIP excursion and any groups wishing to go one way are welcome, however there is NO discounted rate. All groups ordering, no matter what time of year, are committed to these rules. All groups must submit an accurate list of all passengers no later than two weeks prior to departure. **Reservations must be made by the bookkeeper or Principal no individual teacher may book the trip. The contact will be updated at the 2 week mark.**

Meals:

No free meals are provided on board the train. Groups can purchase boxed meals in advance. There is a concession car that is part of the trains consists that groups may purchase food from individually. Cash or credit card is accepted. Schools may bring their own lunches onboard.

Payments and Cancellations:

FULL PAYMENT MUST be paid with in 30 Business days from the date the contact was issued. If payment and contract is not received with in 30 days the reservation WILL BE CANCELED! Make checks payable to SAM Shortline Railroad.

If payment is not made the reservation will be canceled. You can not bring payment to the train on the day of the ride. Payment must be paid 30 days in advance to the depot NO EXCEPTIONS!

Handicap Disclaimer

Walking is required in at anyone of the stops we make. Grounds and step stools may be unstable due to unstable ground. Steps may be high and may require assistance. Motorized wheel chairs and/or scooters accepted onboard the train in coach services ONLY.

Our trips will not be handicap accessible. Historic and antiquated rail passenger equipment, like that used on our excursions, are exempt from ADA regulations under U.S. Code: Title 42: Section 12184. The passenger cars and station facilities used on our excursions were constructed before disability accessibility laws were adopted. Platforms, boarding areas, stairs, step-stools, seating, and especially doorways, passageways, aisles, and on board restrooms may not accommodate all passengers. We will make all reasonable efforts to accommodate differently abled passengers who desire to ride one of our trips.
